1. **Assignment:** To Install, Decorate, Design and Brand both interior and exterior of Assam Pavilion at Pragati Maidan, New Delhi for World Food India, 2023 to be held from 3rd to 5th November, 2023
2. **Eligibility Criteria of Bidders:**
 - a) The bidder should be a private/ Public Ltd. Company registered under the Companies Act, 1956 or a Firm or a Sole Proprietorship Firm
 - b) The Company/Firm must be registered with appropriate authority on all applicable statutory duties/Taxes.
 - c) The bidder must have single handedly executed similar nature of job at National/International Level. Also, the bidder must have minimum 7 years of experience in executing work value of minimum 20 lakhs and above in similar work as per 'd'.
 - d) Similar works means Installing, Decorating, Designing and Branding of Pavilion at National/International level event.
 - e) The agency must a minimum average annual turnover of Rs 1 crore in last 3 Financial Year (FY 2020-21, FY 2021-22 and FY 2022-23).
 - f) The bidder must not be Black Listed by any Government Department/Agency. (Self Certification to be attached)
 - g) The proposals of the bidders, who qualifies in Technical Bid with 60% score, would be only opened in Financial Bid. The Highest Scorer obtained from both Technical and Financial Bid as per QCBS Method would be offered the work order by the authority under the scheme.
 - h) The minimum score for qualifying in the technical bid is 60 % of the 100 Total Marks.

4. **Estimated value of work:** Rs.30,00,000.00 (Rupees Thirty Lakh) only

5. **Work Specification:** The specification of the work of installing, designing, decorating and branding Assam Pavilion in WFI, 2023 is given below:

- a) Installation of Pavilion Size will be of 200 SQ. MT. The Assam Pavilion will consist of a Theme Pavilion, 2.0m X 2.5m MSME stalls (approx. 10 numbers), Display area, Reception, VIP Sitting, Pantry with store, Pavilion Director's office and one stalls for Government Department etc.
- b) Erection and decoration of Assam Pavilion in all floors, front & side fascia, front verandas etc. as per approved design and specification for WFI, 2023
- c) Apart from the Theme Pavilion, the other available space of the interior shall be designed reflecting Theme of WFI 2023 as well as the other unique strength of the state. Design, Decoration and Branding of the Assam Pavilion must reflect the broad theme of the event "India" as Food Basket of the World as well as the cultural ethos and heritage of Assam.

The design shall be imaginative and original, making the best use of available space of the entire Assam Pavilion by providing 2D & 3D models depicting food basket/food culture of Assam & any other models related to theme and heritage of Assam.

- d) Vinyl Printing and Pasting of Stall numbers and names of the units (exhibitors) along with logo.
- e) Painting of Assam Theme Pavilion of both inside and outside as per approved design and direction of the Pavilion Director
- f) Maintenance of Electrical System Including placement of electrician during the entire period as per direction of the Pavilion Director
- g) Installation and operation of Inverter of adequate capacity for catering the following needs (if needed):
 - (i) P.A. System
 - (ii) C. C. TV with recording system.
 - (iii) Emergency lighting
- h) Providing, installation & maintenance of LED screen of size 10' x 16' (approx.) in front side for the entire exhibition period and arrangement of LED Display along with LCD Projector at the main entrance and for playing videos inside Assam Pavilion depicting ethnic foods, food basket, processed food products, dances, tourist spots, historical monuments, industrial development of Assam and theme of the WFI-2023 during the exhibition period. - i) Firefighting arrangement as per MoFPI, Delhi Fire service and Delhi Police regulations for WFI, 2023
- j) Adequate lighting arrangement inside and outside the Pavilion.
- k) Providing Blowups, Flex, Glow Sign, Photographs, Model based on theme of WFI-2023, as well as reflecting the richness of the food delicacies from Assam representing all tribes and communities, cultural heritage, bio –diversity, flora and fauna and other industrial products unique to Assam
- l) Maintenance of the exhibition areas/ office/ reception/ sides front of the Pavilion building
- m) Dismantling and removal of all temporary display items followed by thorough cleaning of the Pavilion after event
- n) Provide Internet Connection in entire Assam Pavilion of required capacity.
- o) Placement of Security Personnel i.e. Security Guard men & women and Security Supervisor from 02-11-2023 to 05-11-2023 and to provide hand hold Metal Detector and Door Frame Metal Detector in each gate.
- p) Special decoration of Assam pavilion at Pragati Maidan, New Delhi on the inauguration day (03-11-2023) with natural flower bouquets, garlands etc. Supplying of Best quality Flower Bouquets and flower vash with fresh flower 30 nos. (15 nos. each day).
- q) Provide 8 nos. two seater sofa set, 5 nos. centre table, carpet (area:65 Sq. Mtr.), 1 no. Lamp Stand (for lighting of lamp), 1 no. podium and supplying of natural flower garlands &

- r) Arrangement of taking still photograph at Assam Pavilion, Pragati Maidan, New Delhi from 8:00 AM to 8:00 PM (from 03-11-2023 to 05-11-2023), video coverage at Assam Pavilion during VVIPs visit throughout the fair period as and when informed and provide 8 (Eight) nos. of best quality albums with important photos placed in the Albums properly (100 photo in each album).
- s) Obtaining necessary approvals/NOC from ITPO, Delhi fire Service, Electricity Authority and Delhi Police for WFI.2023 (if necessary).
- t) Adequate number of Fresh Flower Tubs should be placed in the entire length of the front and inside the pavilion. Further, fresh flower Pots for VIP Lounge, Reception Counters and office Room etc. are to be provided daily for entire fair period. The Flowerpots are to be replaced regularly as per advice of the pavilion Director.
- u) Clean & Hygienic drinking water system/facility should be provided for entire fair period.
- v) Providing adequate face mask and sanitizer in the Pavilion, VIP lounge and Reception counter for the entire period.
- w) All facilities should be provided for reception of VIPs, VVIPs and officials of Pavilion Director's office. Adequate experienced manpower to be provided for the reception etc.
- x) Bamboo wood flooring inside and front of the pavilion and passages/ ramps etc. As regards colour and quality of bamboo wood prior approval of the Pavilion Director to be obtained.
- y) Cleaning the exhibition areas/office/corridors/sides & front of the Assam Pavilion in every two hours from 8:00 AM to 8:00 Pm during the entire period of exhibition.
- z) Fire Extinguishers to be provided as per norms or as per requirement of Delhi Fire Service.
- aa) 'No Smoking' display board/ 'Fire Exit' display board to be provided as per direction of Pavilion Director
- bb) Glow sign of ASSAM in **English, Hindi** and **Assamese** to be provided.
- cc) No transportation charges will be made separately for installation/carrying to the work site.

7. Locations: The agency must have the capability to install, erect, design, decorate and brand the Assam Pavilion at Pragati Maidan, New Delhi for WFI, 2023

8. Scope of Work:

- a) Installing, Designing, Decorating and Branding of Assam Pavilion as per 'Work Specification' mentioned at point no 5 above and to be installed at Pragati Maidan, New Delhi for WFI, 2023 to be held from 03-11-2023 to 05-11-2023
- b) The exercise is time bound and is to be completed as per the time schedule prescribed
 - Submission of Design of Assam Pavilion as per point 5 above and within 2 days of giving work order
 - Submission of work completion report with relevant photographs, videos and visit books on 01-11-2023

- c) No insurance charge is admissible and the successful tenderer will be responsible for any breakage, damage and loss in transit on way to destination. The successful tenderer shall indemnify and keep indemnified AIDC Ltd against all losses and claims for injuries or damages to any person or property whatsoever which may arise out of or in consequence of the construction and maintenance of works and against all claims, demands, proceedings, damages, costs, charges, expenses, whatsoever in respect thereof in relation thereto
- d) Any default or breach of contract or non-execution of supply shall lead to appropriate action by AIDC Ltd. including black listing / delisting the tenderer for future supply/work.
- e) If any item supplied is found to be not of standard quality as specified above, it should be taken back immediately and replaced by fresh one at own cost of supplier.

9. Terms of Payment:

- a) No Advance payment will be made under any circumstances.
- b) No interest can be claimed in case of delay in making payment beyond the stipulated period of payment.
- c) All taxes/charges/duties as applicable will be deducted from the bill.
- d) GST will be paid separately with bill

10. Release of Payment:

100 % payment will be released after submission of original bills/vouchers along with work completion report supported by pictures, videos, visit books

12. Rates

- a) Bidder shall quote the BASIC RATE in Figures per unit (exclusive of all Taxes/ duties etc.)
- b) No subsequent escalation of price will be accepted even in any case.
- c) There shall be no separate re-imburement or increase of rate or payment of compensation in any ground.

14. METHODOLOGY OF EVALUATION- QUALITY CUM COST BASED SELECTION

- A. After fulfilment of the Eligibility Criteria, the evaluation will be done at two stages by the Bid Evaluation Committee in which the Stage I will be Technical Evaluation and Stage II will be Financial Evaluation.
- B. Prior to evaluation of Technical Bid, the AIDC will determine whether each Proposal is responsive to the requirements as per the Bid Document. The AIDC may, in its sole discretion, reject any Proposal that is not responsive hereunder. A Proposal shall be considered responsive only if:
- a. the Technical Proposal is containing requisite documents as mentioned in the Bid Document
 - b. it is signed, sealed, bound together in hard cover and marked as stipulated for Technical bid only. The scanned copy of same to be uploaded in online otherwise the bid will be rejected. it is accompanied by the Power of Attorney as specified; EMD as specified;
 - c. it contains all the information (complete in all respects) as requested in the Bid Document;
 - d. it does not contain any condition or qualification; and
 - e. it is not non-responsive in terms hereof.
 - f. AIDC reserves the right to reject any Proposal which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by the AIDC in respect of such Proposals. The AIDC shall subsequently examine and evaluate Proposals in accordance with the Selection Process and the criteria set out in this Bid Document.
 - g. The combined final score shall be considered for award of the assignment. The assignment shall be awarded to the Bidder scoring the highest final weighted score.
 - h. The weightage for the technical proposal and financial proposal in the combined final score will be 60% and 40% respectively.
 - i. The marking scheme for technical proposal will be as per evaluation criteria defined in Details of Technical score determination at Serial No. 3. Technical score (St) shall be out of 100. Bidders obtaining a total score of 60 per cent (on a scale of maximum total 100 marks) or more on the basis of criteria for evaluation given in Serial No. 3, would be declared technically qualified.
 - j. The Financial Proposals of only those bidders who have achieved the Benchmark Score of 60% will be opened for evaluation. The Financial Proposal shall be evaluated using the following methodology:
 - k. The lowest Financial Proposal (Fm) will be given a financial score (Sf) of 100 points. The financial scores (Sf) of the other Financial Proposals will be determined using the following formula: $Sf = 100 \times Fm/F$;
 - l. In which Sf is the financial score, Fm is the lowest Financial Proposal, and F is the Financial Proposal (in Rs.) under consideration.
 - m. Proposals will finally be ranked in accordance with their combined of technical (St) and financial (Sf) scores: $S = St \times Tw + Sf \times Fw$; where S is the combined score, and Tw and Fw are weights assigned to Technical Proposal and Financial Proposal that will be 60%

and 40% respectively.

15. SELECTION

The Applicant scoring the highest Total Score shall be declared as the “Selected Firm”.

16. GENERAL TERMS AND CONDITIONS OF TENDER

- a) All documents relating to the bid shall be in English language.
- b) The rates are to be quoted both in words and figures.
- c) The rates should be quoted after visiting the site and taking into account the site condition.
- d) The Bidder, at the Bidder’s own responsibility and risk is encouraged to visit and examine site of works and its surroundings and obtain all information that may be necessary for design and preparation of the Bid. The cost of visiting the site shall be at the Bidder’s own expense.
- e) Taxes, as applicable under state and central Govt. norms will be deducted from the bills as per rules.
- f) All pages of the bid document are to be signed and stamped by the bidder.
- g) No materials/machineries will be issued to the contractor for execution of the works.
- h) The tenderer is to submit completion certificate of similar nature of works along with copy of work order from concerned departments with the bid.
- i) The Selection Committee for Assam Pavilion is not bound to allot the work to the lowest tenderer only.
- j) The successful bidder/s have to submit Performance Security of Rs. 60,000.00. The EMD amount submitted by the selected bidder/bidders shall be refunded accordingly.
- k) Every unsuccessful bidder will get back his/her EMD after rejection of bid.
- l) The Selection Committee reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- m) No price escalation or price enhancement will be considered for the works under any circumstances.
- n) Penalty will be imposed on contractors doing sub-standard works or for time delays, if any, as deem fit and proper by the Corporation.
- o) Terms and conditions of the contract as supplied with the tender document along with the Agreement will be final and binding on the contractor. The Performance Security will be released only after release of final payment against the work.
- p) Any other item of works carried out at site but not covered under this bid and the design, shall be paid as per the rate mutually agreed upon between the Pavilion Director and the contractor.
- q) For the part work or for low volume of work, if any, due to any circumstances, amount will be reduced proportionately by the Pavilion Director.
- r) The bidder should be responsible for the work from the date of the work order till completion of

- s) The bidder are to submit copy of the PAN card and GST Registration Certificate along with the bid.
- t) The bidder should submit the action calendar for completion of work within the schedule time i.e. on 25-10-2023. The works must be completed within 1st November, 2023 and handed over to the Pavilion Director.
- u) The selected bidder will be responsible for cleanliness of the entire Assam Pavilion (both inside and outside) all the time during the Fair period.
- v) All disputed arising out of the processing of offers and of work order/letter of intent so made shall be subject to the jurisdiction of Gauhati High Court, Guwahati, Assam.
- w) The execution of work should be carried out as per design approved by the Selection Committee and in consultation with the Pavilion Director accordingly.
- x) The selected bidder has to arrange the accommodation of his working staff by himself outside the pavilion premises.
- y) The technically qualified bidder will be required to make presentation of the design to the Selection Committee on 19th October, 2023. For any change in dates necessary intimation will be made by the committee
