Eligibility criteria (minimum)	<p>(i) The bidder should have the experience of successful execution of similar works under any Govt. agency during the last 7 (seven) years ending last day of month of the previous to the one in which applications are invited meeting any of the following three conditions,</p> <p>a) The bidder must have completed at least one similar nature of work with minimum 24 KLD capacity (80% of maximum capacity), or</p> <p>b) The bidder must have completed at least two similar natures of work with minimum 15 KLD capacity (50% of maximum capacity), or</p> <p>c) The bidder must have completed at least three similar natures of work with minimum 12 KLD capacity (40% of maximum capacity).</p> <p>Similar works shall mean "Design, Engineering, Procurement, Construction, Supply, Installation, Testing, Commissioning, and Handing Over of a STP/WTP/ETP Plant in any project of India".</p> <p>(ii) The past experience in similar nature of work should be supported by work order and completion certificates issued by the client's organization including all other relevant documents.</p> <p>(iii) The value of executed works shall be brought to the current level by enhancing the actual value of work done at a simple rate of 5% per annum, calculated from the last day of month of the previous to the one in which applications are invited.</p> <p>(iv) Joint-venture / consortia of firms / companies shall be allowed and the bidders should meet the above criteria themselves.</p> <p>(v) Should have minimum annual average financial turnover from construction works not less than the estimated cost put to tender during the last 3 (three) financial years ending 31.03.2025.</p>
